7 **A Resolution authorizing the County Executive to advertise for bids for the rehabilitation**  
8 **of four occupied Hope Homes group homes located at 101 Emmitt Road in Tallmadge, 102**  
9 **North Alling in Tallmadge, 2434 Call Road in Stow and 2436 Call Road in Stow, in Council**  
10 **Districts 3 and 6, for an estimated total cost not to exceed \$136,875.00, for the Executive's**  
11 **Department of Community and Economic Development, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for the rehabilitation of  
17 four occupied Hope Homes group homes located at 101 Emmitt Road in Tallmadge, 102 North  
18 Alling in Tallmadge, 2434 Call Road in Stow and 2436 Call Road in Stow, in Council Districts 3  
19 and 6, for an estimated total cost not to exceed \$136,875.00; and

21 WHEREAS, a copy of the specifications are on file with the Clerk of Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 advertise for bids for the aforementioned rehabilitation project;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that;

32 The County Executive is authorized to advertise for bids for the rehabilitation of four  
33 occupied Hope Homes group homes located at 101 Emmitt Road in Tallmadge, 102 North Alling  
34 in Tallmadge, 2434 Call Road in Stow and 2436 Call Road in Stow, in Council Districts 3 and 6,  
35 for an estimated total cost not to exceed \$136,875.00.

39 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
40 of the citizens of the County of Summit, and for the further reason that it authorizes the  
41 Executive to immediately advertise for bids for the rehabilitation of four occupied Hope Homes  
42 group homes located at 101 Emmitt Road in Tallmadge, 102 North Alling in Tallmadge, 2434  
43 Call Road in Stow and 2436 Call Road in Stow, in Council Districts 3 and 6 in 2014.
