7 **A Resolution confirming an award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with The Goodwill Industries of Akron, Ohio, Inc., for**
9 **additional adult and dislocated worker and universal employment services, and to extend**
10 **the period of the contract from 7/1/14 through 8/15/14, in an amount not to exceed**
11 **\$98,000.00 (10% cumulative increase), for the Executive's Department of Job and Family**
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held June 11, 2014, awarded Change
15 Order No. 1 to a professional service contract with The Goodwill Industries of Akron, Ohio, Inc.,
16 for additional adult and dislocated worker and universal employment services, and to extend the
17 period of the contract from 7/1/14 through 8/15/14, in an amount not to exceed \$98,000.00 (10%
18 cumulative increase), subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, by reviewing all pertinent information,
21 that the change order is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

28 The award by the Board of Control of Change Order No. 1 to a professional service
29 contract with The Goodwill Industries of Akron, Ohio, Inc., for additional adult and dislocated
30 worker and universal employment services, and to extend the period of the contract from 7/1/14
31 through 8/15/14, in an amount not to exceed \$98,000.00 (10% cumulative increase), is hereby
32 confirmed and the County Executive is hereby authorized to execute such change order.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide additional employment services effective 7/1/14.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
