7 **A Resolution authorizing the County Executive to execute a professional service contract**  
8 **with SirsiDynix EOS, LLC, dba EOS, as Best Practical Source, subject to the approval of**  
9 **the Board of Control, for the EOS Web Express Cloud product suite for cataloging, for the**  
10 **Law Library Resources Board in its operation of the Law Library, for a five-year term**  
11 **from 6/1/14 through 5/31/19, for an amount not to exceed \$42,568.00 for the five-year term**  
12 **of the contract, to be paid by Akron Bar Association Foundation through its Akron Law**  
13 **Library Association Fund, for the Law Library Resources Board, and declaring an**  
14 **emergency.**

15  
16 WHEREAS, the Akron Law Library Association previously operated the Law Library,  
17 located on the fourth floor of the County of Summit Courthouse; and

18  
19 WHEREAS, the Ohio General Assembly enacted 2008 Amended Substitute Ohio House  
20 Bill 420, which established county law library resource boards to operate law libraries; and

21  
22 WHEREAS, the County of Summit Law Library Resources Board took over operation of  
23 the Law Library on 1/1/10; and

24  
25 WHEREAS, County Council previously adopted Amended Resolution No. 2011-246,  
26 which authorized the County Executive to execute any documents necessary to assume, effective  
27 1/1/10, on behalf of the Board, a five-year professional service contract with EOS International  
28 for Software-as-a-Service e-Library Service for remote web hosting of the Library's Online  
29 Public Access Catalogue, circulation, serials and internal cataloging modules, for the period  
30 6/1/09 through 5/31/14, for a total amount not to exceed \$37,324.00, of which the Board was  
31 responsible for payment of an amount not to exceed \$21,464.00; and

33 WHEREAS, because the Law Library has used products from SirsiDynix EOS, LLC, dba  
34 EOS, in the past for cataloging and it is a Best Practical Source for that purpose; and

35  
36 WHEREAS it is necessary to authorize the County Executive to execute a professional  
37 service contract with SirsiDynix EOS, LLC, dba EOS, as Best Practical Source, subject to the  
38 approval of the Board of Control, for the EOS Web Express Cloud product suite for cataloging,  
39 for the Law Library Resources Board in its operation of the Law Library, for a five-year term  
40 from 6/1/14 through 5/31/19, for an amount not to exceed \$42,568.00 for the five-year term of  
41 the contract; and

43 WHEREAS, the aforementioned professional service contract will be paid by Akron Bar  
44 Association Foundation through its Akron Law Library Association Fund; and

45  
46 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
47 that it is necessary and in the best interest of the County to authorize the Executive to execute the  
48 aforementioned professional service contract with SirsiDynix EOS, LLC, dba EOS, as Best  
49 Practical Source, subject to the approval of the Board of Control;

9 The County Executive is hereby authorized to execute a professional service contract  
10 with SirsiDynix EOS, LLC, dba EOS, as Best Practical Source, subject to the approval of the  
11 Board of Control, for the EOS Web Express Cloud product suite for cataloging, for the Law  
12 Library Resources Board in its operation of the Law Library, for a five-year term from 6/1/14  
13 through 5/31/19, for an amount not to exceed \$42,568.00 for the five-year term of the contract, to  
14 be paid by Akron Bar Association Foundation through its Akron Law Library Association Fund.

16 The annual cost of the professional service contract shall be as follows:
