7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO, and the Executive, for the period 4/1/14**
10 **through 3/31/17, and declaring an emergency.**

12 WHEREAS, a collective bargaining agreement has been reached between the County
13 Executive and Ohio Council 8 and Local 1229 of the American Federation of State, County and
14 Municipal Employees, AFL-CIO, for the period 4/1/14 through 3/31/17; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that is necessary and in the best interest of the County of Summit to authorize the Executive to
18 execute the aforementioned collective bargaining agreement;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The County Executive is hereby authorized to execute a collective bargaining agreement
26 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
27 Municipal Employees, AFL-CIO, and the Executive, for the period 4/1/14 through 3/31/17.

29 SECTION 2

31 This Resolution is hereby declared an emergency in the interest of the health, safety, and
32 welfare of the citizens of the County of Summit and for the further purpose of providing a timely
33 collective bargaining agreement between Ohio Council 8 and Local 1229 of the American
34 Federation of State, County and Municipal Employees, AFL-CIO, and the County Executive.

38 Provided this Resolution received the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
47 were in meetings open to the public, in compliance with all legal requirements, including Section
48 121.22 of the Ohio Revised Code.

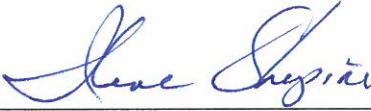
