7 **A Resolution authorizing the County Executive to advertise for bids for the construction of**  
8 **the Waste Water Treatment Plant #32 Sanitary Sewer Collection System Rehabilitation**  
9 **Project Q-833, in Council District 7, for an estimated total cost not to exceed \$98,310.00, for**  
10 **the Executive's Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the construction of the  
16 Waste Water Treatment Plant #32 Sanitary Sewer Collection System Rehabilitation Project Q-  
17 833, in Council District 7, for an estimated total cost not to exceed \$98,310.00; and

19 WHEREAS, a copy of the plans and specifications are on file with the Clerk of Council;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
24 advertise for bids for the construction of the Waste Water Treatment Plant #32 Sanitary Sewer  
25 Collection System Rehabilitation Project Q-833, in Council District 7;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that;

32 The County Executive is authorized to advertise for bids for the construction of the Waste  
33 Water Treatment Plant #32 Sanitary Sewer Collection System Rehabilitation Project Q-833, in  
34 Council District 7, for an estimated total cost not to exceed \$98,310.00.

38 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
39 of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for the Waste Water Treatment Plant #32 Sanitary  
41 Sewer Collection System Rehabilitation Project Q-833, in Council District 7.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


