11 WHEREAS, the Board of Control, at its meeting held July 23, 2014, awarded a purchase
12 order with Montrose Ford for two 2014 Ford Edges and two 2015 Ford Escapes, under CUE
13 pricing, subject to confirmation by County Council; and

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the purchase order is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
19 of Ohio, that:

23 The award by the Board of Control of a purchase order with Montrose Ford for two 2014
24 Ford Edges and two 2015 Ford Escapes, under CUE pricing, in a total amount not to exceed
25 \$89,695.12, is hereby confirmed and the County Executive is hereby authorized to execute such
26 purchase order.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide for the vehicles in 2014.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
