A Resolution confirming an award by the Board of Control of a professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a term of one year, from 11/1/14 through 10/31/15, at a cost of \$6.50 per employee per month, for a total amount not to exceed \$195,000.00, with two options to renew for an additional one-year term, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, in 2013, pursuant to Section 177.07(a)(10) of the Codified Ordinances of the County of Summit, the County of Summit selected Wellness IQ, Inc. ("Wellness IQ"), to provide vitality wellness services to and for the benefit of County employees and employees of other entities participating in the County's health insurance plan, at a rate and under terms and conditions equal to or more favorable than were offered to another Ohio political subdivision, Cuyahoga County, after that subdivision completed a competitive selection procedure; and

WHEREAS, this Council previously adopted Resolution No. 2013-381, which confirmed an award by the Board of Control of a professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of County employees and employees of other entities participating in the County's health insurance plan, for a term of one year, from 11/1/13 through 10/31/14, at a cost of \$6.50 per employee per month, plus an initial setup fee of \$5,000.00, for a total amount not to exceed \$200,000.00; and

WHEREAS, the County wishes to enter into a new professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of County employees and employees of other entities participating in the County's health insurance plan; and

WHEREAS, the Board of Control, at its meeting held August 27, 2014, awarded a professional service contract with Wellness IQ, Inc., to provide vitality wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a term of one year, from 11/1/14 through 10/31/15 at a cost of \$6.50 per employee per month, for a total amount not to exceed \$195,000.00, with two options to renew for an additional one-year term; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to confirm the award of the Board of Control of a professional service contract with Wellness IQ to provide vitality wellness services to and for the benefit of County employees and employees of other entities participating in the County's health insurance plan, for a term of one year, from 11/1/14 through 10/31/15, at a cost of \$6.50 per employee per month, for a total amount not to exceed \$195,000.00, with two options to renew for an additional one-year term;

SECTION 1

The award of the Board of Control of a professional service contract with Wellness IQ, Inc. ("Wellness IQ"), to provide vitality wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a term of one year, from 11/1/14 through 10/31/15, at a cost of \$6.50 per employee per month, plus an initial set up fee of \$5,000.00, for a total amount not to exceed \$195,000.00, with two options to renew for an additional one-year term, is hereby confirmed and the County Executive is authorized to execute said contract.
