7 **A Resolution certifying deferred sewer tap-in fees to the Fiscal Officer, for the Executive's**
8 **Department of Environmental Services, and declaring an emergency.**
9

10 WHEREAS, Section 923.05(c) of Title V of the Codified Ordinances of the County of
11 Summit provides financially disadvantaged residents, charitable agencies and public institutions
12 the option of placing their tap-in fee on their property tax duplicate, without interest, for a
13 period not to exceed five years under an extended payment program administered by the
14 Executive's Department of Environmental Services; and
15

16 WHEREAS, Section 923.05(d) of Title V of the Codified Ordinances of the County of
17 Summit provides multiple residential, commercial and industrial users the option of placing
18 part of their sewer tap-in fee on their property tax duplicate, without interest, for a period not
19 to exceed two years under an extended payment program administered by the Executive's
20 Department of Environmental Services; and

22 WHEREAS, Section 923.05(c) and (d) of Title V of the Codified Ordinances of the
23 County of Summit provides that said deferred fees are to be certified to the Fiscal Officer and
24 placed on the property tax duplicate for collection; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that certifying the aforementioned charges to the Fiscal Officer is necessary and in the best
28 interests of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The sewer tap-in fees of the following participants in the County's extended payment
36 program are certified to the Fiscal Officer to be placed on the tax list and duplicate and collected
37 as other taxes are collected in the annual installments as stated below, payable semiannually
38 without interest, as provided by Section 923.05(c) and (d) of Title V of the Codified Ordinances
39 of the County of Summit and Section 6117.02(B) of the Ohio Revised Code.
