WHEREAS, the non-bargaining classified position of Cross Connection Backflow Coordinator #34030 at the County Executive's Department of Environmental Service ("DOES") "coordinates a comprehensive program of backflow prevention, and lead and copper testing and inspection as related to commercial/industrial and residential water customers" among other duties related to water services, as set forth in the classification specification attached to this Resolution as Exhibit A; and

WHEREAS, because the County no longer provides water services to Summit County residents, the position is no longer needed at DOES; and
