7 **A Resolution approving renaming the non-bargaining classified position of Jail Population**
8 **Control Administrator # 29221 as Jail Population Control Coordinator # 29221, approving**
9 **changing the pay category and grade of said position from a Category 3, Grade 6 to a**
10 **Category 2, Grade 6 and amending the County's 2014 Staffing Report to reflect the name**
11 **change of said position, for the Human Resource Commission and the Executive's**
12 **Department of Human Resources, and declaring an emergency.**

14 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
15 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
16 Codified Ordinances of the County of Summit to establish classifications, classification
17 specifications and pay/salary schedules for all County employees; and

18
19 WHEREAS, the County Sheriff has requested pursuant to Section 169.11 that the Human
20 Resource Commission ("HRC") approve renaming the non-bargaining classified position of Jail
21 Population Control Administrator # 29221 as Jail Population Control Coordinator # 29221 and
22 that the pay category and grade of said position be changed from a Category 3, Grade 6 to a
23 Category 2, Grade 6 due to a reduction in responsibilities; and

25 WHEREAS, the Human Resource Commission, at its September 19, 2014 meeting,
26 approved renaming the non-bargaining classified position of Jail Population Control
27 Administrator # 29221 as Jail Population Control Coordinator # 29221 and approved changing
28 the pay category and grade of said position from a Category 3, Grade 6 to a Category 2, Grade 6,
29 as set forth in HRC Order No. 14-12, attached to this Resolution as Exhibit A; and

31 WHEREAS, it is necessary to amend the County's 2014 Staffing Report, attached as
32 Exhibit A to Amended Resolution No. 2013-494 previously adopted by this Council, to reflect
33 the name change of said position; and

35 WHEREAS, this Council has determined by reviewing all pertinent information that it is
36 necessary and in the best interest of the County of Summit to approve renaming the non-
37 bargaining classified position of Jail Population Control Administrator # 29221 as Jail
38 Population Control Coordinator # 29221, approve changing the pay category and grade of said
39 position from a Category 3, Grade 6 to a Category 2, Grade 6, and amend the County's 2014
40 Staffing Report to reflect the name change of said position;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The following non-bargaining classification:

49 **Jail Population Control Administrator # 29221 is hereby renamed: Jail Population Control**
50 **Coordinator # 29221.**

6 The classification specification for this classification, attached to this Resolution as Exhibit B, is
7 hereby approved and shall replace the classification specification for Jail Population Control
8 Administrator previously approved by Resolution No. 2006-304 adopted by County Council.

12 The following hourly pay scale for Category 2, Pay Grade 6, as shown in the point factor scoring
13 sheet attached to this Resolution as Exhibit C, is hereby approved for said position:

16 The hourly pay scale for Category 2, Pay Grade 6 shall replace the hourly pay scale for Category
17 3, Pay Grade 6 for Jail Population Control Administrator #29221 previously approved by
18 Resolution No. 2006-304 adopted by County Council.

20 SECTION 3

22 The County's 2014 Staffing Report is hereby amended to change Jail Population Control
23 Admin (1) to Jail Population Control Coordinator (1).

25 SECTION 4

27 This Resolution is hereby declared an emergency in the interest of the health, safety and
28 welfare of the citizens and employees of the County of Summit, and for the further reason that it
29 is necessary in order to immediately approve renaming the non-bargaining classified position of
30 Jail Population Control Administrator # 29221 as Jail Population Control Coordinator # 29221,
31 approve changing the pay category and grade of said position from a Category 3, Grade 6 to a
32 Category 2, Grade 6, and amend the County's 2014 Staffing Report to reflect the name change of
33 said position.

35 SECTION 5

37 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
39 and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
