7 **A Resolution confirming an award by the Board of Control of purchase contract with**
8 **Kenworth of Richfield for a tractor cab and chassis with fifth wheel wet connection, in an**
9 **amount not to exceed \$140,780.00, for the Executive's Department of Environmental**
10 **Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held October 8, 2014, awarded a
13 purchase contract with Kenworth of Richfield for a tractor cab and chassis with fifth wheel wet
14 connection, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

22 SECTION 1

24 The award by the Board of Control of a purchase contract with Kenworth of Richfield for
25 a tractor cab and chassis with fifth wheel wet connection, in an amount not to exceed
26 \$140,780.00, is hereby confirmed and the County Executive is hereby authorized to execute such
27 purchase contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately meet
33 requirements of an Ohio Environmental Protection Agency consent order and to replace sludge
34 hauling services currently provided by an outside vendor.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
47 were in meetings open to the public, in compliance with all legal requirements, including Section
48 121.22 of the Ohio Revised Code.


