7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the Portage County Water Resources Department for construction costs**
9 **for the Streetsboro Wastewater Treatment Plant Bio Solids Reduction Facility Project, in**
10 **Council Districts 1 and 3, in an amount not to exceed \$653,364.58, and appropriating funds**
11 **in an amount not to exceed \$653,364.58 for the period ending 12/31/14, for the Executive's**
12 **Department of Environmental Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held October 29, 2014, awarded an
15 intergovernmental agreement with the Portage County Water Resources Department for
16 construction costs for the Streetsboro Wastewater Treatment Plant Bio Solids Reduction Facility
17 Project, in Council Districts 1 and 3, subject to confirmation by County Council; and

19 WHEREAS, it is necessary to appropriate funds to pay for said construction costs out of
20 the Sewer Enterprise Fund; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the agreement is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The award by the Board of Control of an intergovernmental agreement with the Portage
31 County Water Resources Department for construction costs for the Streetsboro Wastewater
32 Treatment Plant Bio Solids Reduction Facility Project, in Council Districts 1 and 3, in an amount
33 not to exceed \$653,364.58, is hereby confirmed and the County Executive is hereby authorized
34 to execute such contract.
