A Resolution authorizing the County Executive to execute a professional service contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, to provide stop-loss reinsurance for County employees for a one-year term, from 1/1/15 through 12/31/15, in an amount not to exceed \$25.97 per employee per month, for a total amount not to exceed \$782,799.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2014-421, which confirmed an award by the Board of Control of a renewal of a professional service contract (second of two) with Employee Benefits International, Inc., for a total amount not to exceed \$140,395.00, of which an amount not to exceed \$115,395.00 is for general consulting services for health and wellness benefits, and an amount not to exceed \$25,000.00 is for benefit regionalization initiatives which are passed through to regionalized political subdivisions, for the period 7/1/14 through 6/30/15; and

WHEREAS, on behalf of the County of Summit, EBI prepared a request for proposals for stop-loss reinsurance for County employees and the County has selected Medical Mutual of Ohio to provide said stop-loss insurance; and

WHEREAS, the Executive's Department of Law, Insurance and Risk Management recommends that the County Executive be authorized to execute a professional service contract with Medical Mutual of Ohio, subject to the approval of the Board of Control, to provide stoploss reinsurance for County employees for a one-year term, from 1/1/15 through 12/31/15, in an amount not to exceed \$25.97 per employee per month, for a total amount not to exceed \$782,799.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract is necessary and in the best interest of the County of Summit;
