7 **A Resolution authorizing the County Executive to advertise for bids for a construction**
8 **contract, for the Court of Common Pleas General Division Technology Improvement**
9 **Project, for an estimated cost not to exceed \$95,000.00, for the Executive's Department of**
10 **Administrative Services – Division of Physical Plants, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, the County Executive wishes to advertise for bids for the Court of Common
16 Pleas General Division Technology Improvement Project for the installation of electrical power,
17 floor boxes and data conduits for future technology in the Judge Tom Teodosio's Courtroom for
18 an estimated amount not to exceed \$95,000.00; and

20 WHEREAS, currently only five of the twelve courtrooms within the Common Pleas
21 Court are equipped to house new technology and this installation would allow an additional
22 courtroom to also house new technology; and

24 WHEREAS, the aforementioned project will be funded using Court of Common Pleas –
25 General Division Special Projects fund; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County to authorize the Executive to advertise
29 for bids for a construction contract for the Court of Common Pleas General Division Technology
30 Improvement Project, as set forth above.

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is authorized to advertise for bids for a construction contract for
38 the Court of Common Pleas General Division Technology Improvement Project for the
39 installation of electrical power, floor boxes and data conduits for future technology in Judge Tom
40 Teodosio's Courtroom, for an estimated total cost not to exceed \$95,000.00. A copy of the plans
41 and specification is on file in the Council office.

45 This Resolution is hereby declared an emergency in the interest of the health, safety, and
46 welfare of the citizens of the County of Summit and for the further reason that it allows the
47 County Executive to immediately advertise for bids and proceed with the aforementioned
48 project.
