7 **A Resolution confirming an award by the Board of Control of a purchase contract with Q-**
8 **Matic Corporation, as Best Practical Source, to provide maintenance and support services**
9 **for the Executive's Department of Job and Family Services' electronic customer service**
10 **queuing system, for a one-year term, from 01/01/15 through 12/31/15, in an amount not to**
11 **exceed \$32,726.12, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held November 19, 2014, awarded a
15 purchase contract with Q-Matic Corporation, as Best Practical Source, to provide maintenance
16 and support services for the Executive's Department of Job and Family Services' electronic
17 customer service queuing system, for a one-year term, from 01/01/15 through 12/31/15, in an
18 amount not to exceed \$32,726.12, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned purchase contract is necessary and in the best interest of the County of
22 Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The award by the Board of Control of a purchase contract with Q-Matic Corporation, as
30 Best Practical Source, to provide maintenance and support services for the Executive's
31 Department of Job and Family Services' electronic customer service queuing system, for a one-
32 year term, from 01/01/15 through 12/31/15, in an amount not to exceed \$32,726.12, is hereby
33 confirmed and the County Executive is hereby authorized to execute such purchase contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 authorize the Executive to execute a necessary purchase contract to provide maintenance and
40 support services for the Executive's Department of Job and Family Services' electronic customer
41 service queuing system.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take






