7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Gardiner Services Company for a five-year, full maintenance service contract for heating,**
9 **ventilation and air conditioning, for the courthouse, for the period 1/1/15 through 12/31/19,**
10 **in Council District 4, in an amount not to exceed \$237,285.00, for the Executive's**
11 **Department of Administrative Services – Physical Plants, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held December 3, 2014, awarded a
14 purchase contract with Gardiner Services Company for a five-year, full maintenance service
15 contract for heating, ventilation and air conditioning, for the courthouse, for the period 1/1/15
16 through 12/31/19, in Council District 4, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Gardiner Services
27 Company for a five-year, full maintenance service contract for heating, ventilation and air
28 conditioning, for the courthouse, for the period 1/1/15 through 12/31/19, in Council District 4, in
29 an amount not to exceed \$237,285.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for heating, ventilation and air conditioning service for the courthouse, in Council
37 District 4, effective 1/1/15.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.
