7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **ComDoc for managed print services to include toner, parts, maintenance, service and labor**
9 **for DJFS printers, for the period 2/28/15 to 2/27/16, approved by the IT Board 12/2/14,**
10 **under Sourcing Alliance Pricing, in an amount not to exceed \$30,000.00, for the Executive's**
11 **Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held December 3, 2014, awarded a
14 purchase order with ComDoc for managed print services to include toner, parts, maintenance,
15 service and labor for DJFS printers, for the period 2/28/15 to 2/27/16, approved by the IT Board
16 12/2/14, under Sourcing Alliance Pricing, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the purchase order is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase order with ComDoc for managed print
27 services to include toner, parts, maintenance, service and labor for DJFS printers, for the period
28 2/28/15 to 2/27/16, approved by the IT Board 12/2/14, under Sourcing Alliance Pricing, in an
29 amount not to exceed \$30,000.00, is hereby confirmed and the County Executive is hereby
30 authorized to execute such purchase order.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for the print services agreement effective 2/28/15.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all

50 121.22 of the Ohio Revised Code.






