A Resolution confirming the award by the Board of Control of Change Order No. 1 to a professional service contract with the United Way of Summit and Medina fka United Way of Summit County to provide 2-1-1 information and referral services to assist low income families in accessing non-profit and government services to meet basic needs, for the period 10/1/20 through 9/30/21, in an amount not to exceed \$200,000.00 (for a cumulative increase of 200%) for a total amount not to exceed \$300,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2020-187, which confirmed the award by the Board of Control of professional service contracts with certain providers for State Fiscal Year 2021 of Title XX funded services and Temporary Assistance to Needy Families ("TANF") funded services, from 7/1/20 through 6/30/21, and from 10/1/20 through 9/30/21, in a total amount not to exceed \$500,000.00; which included an award to with the United Way of Summit and Medina fka United Way of Summit County (the "United Way"), as a Best Practical Source, to provide 2-1-1 information and referral services to assist low income families in accessing non-profit and government services to meet basic needs, for the period 10/1/20 through 9/30/21, in an amount not to exceed \$100,000.00; and

WHEREAS, pursuant to the professional service contract, the United Way provides 2-1-1 information and referral services to assist low income families in accessing nonprofit and government services to meet basic needs (such as food, affordable housing, utility assistance, clothing and low cost health care services), as well as preventative services and resources to attain self-sufficiency; and
