7 **A Resolution rescinding Resolution 2021-080, which set a public hearing for a petition for**
8 **annexation filed with the Council Office March 15, 2021 and cancelling the aforementioned**
9 **public hearing date scheduled for May 24, 2021, for Council, and declaring an emergency.**

11 WHEREAS, this Council, on March 15, 2021 received a petition for annexation of
12 118.7873 acres of land in Richfield Township to the Village of Richfield; and

13
14 WHEREAS, the Council Office received a letter March 25, 2021 requesting Council
15 withdraw the annexation petition filed with County Council March 15, 2021; and

16
17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that it is necessary and in the best interest of the County of Summit that the annexation petition
19 filed with County Council on March 15, 2021 be withdrawn and the public hearing date
20 scheduled for May 24, 2021 be cancelled.

22 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The annexation petition filed with County Council on March 15, 2021 is hereby
28 withdrawn and the public hearing date scheduled for May 24, 2021 is cancelled.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the residents of the County of Summit and for the further reason to immediately
34 rescind Resolution 2021-080 and withdraw the annexation petition filed with County Council on
35 March 15, 2021 and cancel the public hearing date scheduled for May 24, 2021.

37 SECTION 3

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
48 were in meetings open to the public, in compliance with all legal requirements, including Section
49 121.22 of the Ohio Revised Code.


