7 **A Resolution approving and authorizing the Executive to execute and submit the**  
8 **Community Development Block Grant and HOME Investment Partnership Program 2021**  
9 **Action Plan to the U.S. Department of Housing and Urban Development for program year**  
10 **2021 and authorizing the Executive to execute the 2021 Community Development Block**  
11 **Grant and HOME Investment Partnership Program contracts, for the Executive's**  
12 **Department of Community and Economic Development, and declaring an emergency.**

14 WHEREAS, as a prerequisite for receiving Community Development Block Grant  
15 ("CDBG") and Home Investment Partnership Program ("HOME") funding for program year  
16 2021, the County is required to submit a 2021 Action Plan to the U.S. Department of Housing  
17 and Urban Development ("HUD") by April 30, 2021; and

18  
19 WHEREAS, the County of Summit anticipates receiving \$981,336.00 in CDBG funding  
20 and \$424,134.00 in HOME funding for the 2021 program year; and

21  
22 WHEREAS, the County of Summit CDBG Review Committee has reviewed and  
23 approved the 2021 CDBG projects and recommended project funding for the activities set forth  
24 in Exhibit A; and

26 WHEREAS, the Department of Community and Economic Development has prepared  
27 the 2021 Action Plan for CDBG and HOME programs, which is due to HUD by April 30, 2021;  
28 and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
31 that it is necessary and in the best interest of the County of Summit to approve and authorize the  
32 Executive to execute and submit the 2021 Action Plan for the CDBG and HOME activities to  
33 HUD;

35 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
36 of Ohio, that:

40 The Executive is hereby authorized to execute and submit the 2021 Action Plan to the  
41 U.S. Department of Housing and Urban Development ("HUD") for the 2021 program year for  
42 Community Development Block Grant ("CDBG") and Home Investment Partnership Program  
43 ("HOME") federal funding awards; said 2021 Action Plan activities shall include the activities as  
44 set forth in Exhibit A, which is attached hereto and incorporated herein as if fully restated.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
7 welfare of the residents of the County of Summit and for the further purpose to immediately  
8 authorize the Executive to execute and submit the CDBG and HOME 2021 Action Plan to HUD  
9 by the April 30, 2021 deadline and to immediately facilitate CDBG and HOME funding for the  
10 program year 2021.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take  
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and be in force at the earliest time provided by law.

20 It is found and determined that all formal actions of this Council concerning and relating  
21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
22 deliberations of this Council and of any of its committees that resulted in such formal action,

24 121.22 of the Ohio Revised Code.
