7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Spano Brothers Construction Co., Inc. for the 2021 Summit County Concrete Pavement**
9 **Repair Program, in an amount not to exceed \$265,911.00, for the Engineer, and declaring**
10 **an emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2020-416, which authorized
13 the Executive to advertise, as needed, for bridge engineering and construction projects, and
14 pavement maintenance projects, for the Engineer's 2021 Capital Improvements Program, and
15 federal and state funded projects, for an estimated total cost not to exceed \$9,117,500.00; and

16
17 WHEREAS, said projects were approved as part of the Capital Improvements Program
18 for 2021-2026 by Resolution No. 2021-037; and

19
20 WHEREAS, following the receipt and review of bids, the Executive proposes entering
21 into a construction contract with Spano Brothers Construction Co., Inc. for the 2021 Summit
22 County Concrete Pavement Repair Program, in an amount not to exceed \$265,911.00; and

24 WHEREAS, the proposed work to be performed by Spano Brothers Construction Co.,
25 Inc. will consist of saw cutting as needed, removing concrete slabs and pouring new concrete for
26 County, Bath Township, Sagamore Hills Township, Twinsburg Township and Twinsburg
27 Township Alternate roads; and

29 WHEREAS, the contract total in an amount not to exceed \$265,911.00 will be broken
30 down by political subdivision as follows with each subdivision responsible for directly paying
31 the contractor:

35 Sagamore Hills Township: \$68,075.00
36 Twinsburg Township: \$24,186.00
37 Twinsburg Township Alternate: \$53,150.00

41 WHEREAS, the Board of Control, at its meeting held April 14, 2021, awarded a
42 construction with Spano Brothers Construction Co., Inc., as the lowest responsive and
43 responsible bidder, for the 2021 Summit County Concrete Pavement Repair Program, in an
44 amount not to exceed \$265,911.00, subject to confirmation by this Council; and

46 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
47 that aforementioned construction contract with Spano Brothers Construction Co., Inc. is
48 necessary and in the best interest of the County of Summit;

5 Ohio, that;

7 SECTION 1

8
9 The award by the Board of Control of a construction contract with Spano Brothers
10 Construction Co., Inc., as the lowest responsive and responsible bidder, for the 2021 Summit
11 County Concrete Pavement Repair Program, in an amount not to exceed \$265,911.00, is hereby
12 confirmed and the Executive is hereby authorized to execute said construction contract and any
13 other necessary related documents.

15 SECTION 2

17 This Resolution is hereby declared an emergency in the interest of the health, safety and
18 welfare of the residents of the County of Summit, and for the further purpose to immediately
19 provide a necessary construction contract for the 2021 Summit County Concrete Pavement
20 Repair Program.

24 Provided this Resolution receives the affirmative vote of eight members, it shall take
25 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
26 effect and be in force at the earliest time provided by law.

30 It is found and determined that all formal actions of this Council concerning and relating
31 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
32 deliberations of this Council and of any of its committees that resulted in such formal action,

34 121.22 of the Ohio Revised Code.


