7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Rolta AdvizeX Technologies LLC, at State Term Pricing, for support for**
9 **Blade/SAN infrastructure in the Ohio Building, for a one-year term, from 3/20/21 through**
10 **3/19/22, in an amount not to exceed \$65,968.16, for the Office of Information Technology,**
11 **and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held April 14, 2021, awarded a
14 professional service contract with Rolta AdvizeX Technologies LLC, at State Term Pricing,
15 approved by the IT Board on April 8, 2021, for support for Blade/SAN infrastructure in the Ohio
16 Building, for a one-year term, from 3/20/21 through 3/19/22, in an amount not to exceed
17 \$65,968.16, subject to confirmation by this Council; and

19 WHEREAS, the Office of Information Technology has contracted with Rolta AdvizeX
20 Technologies LLC since 2017 to provide these services; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned professional service contract with Rolta AdvizeX Technologies LLC is
24 necessary and in the best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

31 The award by the Board of Control of a professional service contract with Rolta AdvizeX
32 Technologies LLC, at State Term Pricing, approved by the IT Board on April 8, 2021, for
33 support for Blade/SAN infrastructure in the Ohio Building, for a one-year term, from 3/20/21
34 through 3/19/22, in an amount not to exceed \$65,968.12, is hereby confirmed and the Executive
35 is hereby authorized to execute said professional service contract and any other necessary related
36 documents.

41 welfare of the residents of the County of Summit, and for the further reason of immediately
42 providing necessary for support for Blade/SAN infrastructure in the Ohio Building effective
