7 **A Resolution confirming the award by the Board of Control of a Temporary Assistance to**
8 **Needy Families Agreement with Greenleaf Family Center, to provide automotive repairs**
9 **and related services to recently employed Temporary Assistance to Needy Families eligible**
10 **clients, from 6/1/21 through 9/30/22, in an amount not to exceed \$200,000.00, for the**
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Executive's Department of Jobs ("DJFS") seeks to enter an agreement
14 with Greenleaf Family Center for automobile repairs and related services to recently employed
15 TANF eligible clients. Services will include transportation case management, automotive
16 education and advocacy, in addition to facilitation of automobile repairs and maintenance
17 services; and

18
19 WHEREAS, the Greenleaf Family Center has provided services for various Summit
20 County agencies and Courts since 2009; and

21
22 WHEREAS, the Executive wishes to enter into a Temporary Assistance to Needy
23 Families ("TANF") Agreement with Greenleaf Family Center to provide automotive repairs and
24 related services to recently employed TANF eligible clients of DJFS; and

25
26 WHEREAS, this agreement will be funded utilizing TANF funds; and

27
28 WHEREAS, the Board of Control, at its meeting held May 19, 2021, awarded a TANF
29 Agreement with Greenleaf Family Center, which is exempt from competitive bidding due to the
30 provider's subgrantee status, for automobile repairs and related services to recently employed
31 TANF eligible clients, from 6/1/21 through 9/30/22, in an amount not to exceed \$200,000.00,
32 subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that the aforementioned TANF Agreement with Greenleaf Family Center is necessary and in the
36 best interest of the County of Summit;

38 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The award by the Board of Control of a Temporary Assistance to Needy Families
44 ("TANF") Agreement for automobile repairs and related services to recently employed TANF
45 eligible clients, from 6/1/21 through 9/30/22, in an amount not to exceed \$200,000.00, is hereby
46 confirmed and the Executive is hereby authorized to execute said professional agreement and
47 any necessary related documents.
