A Resolution confirming the award of a professional service contract with NFP Corporate Services for general consulting services for health and wellness benefits, for a one-year term, from 10/1/21 to 9/30/22, with four options to renew for an additional one-year term, for an amount not to exceed \$235,000.00, for the Executive's Department of Human Services-Division of Employee Benefits, and declaring an emergency.

WHEREAS, the County's share of the professional service contract with NFP, for a one year term, shall be \$120,000.00, with up to \$115,000.00 being paid by regionalized entities who participate in the County's self-insured plan, as outlined in Exhibit A, a copy of which is attached hereto and incorporated fully herein to the resolution; and

WHEREAS, the Board of Control, at its meeting on June 9, 2021, awarded a professional service contract with NFP Corporate Services for general consulting services for health and wellness benefits, for a one-year term, from 10/1/21 to 9/30/22, with four options to renew for an additional one-year term, for an amount not to exceed \$235,000.00, subject to confirmation by this Council; and
