7 **A Resolution authorizing the County Executive to advertise for bids for the Q-615 Pump**  
8 **Station No. 81 Force Main Replacement Project, located in the City of Tallmadge, in**  
9 **Council District 6, for an estimated total cost not to exceed \$440,000.00, for the County**  
10 **Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

11  
12 WHEREAS, the Executive wishes to advertise for bids for the Q-615 Pump Station No.  
13 81 Force Main Replacement Project (the "Project"), located in the City of Tallmadge, in Council  
14 District 6, for an estimated total cost not to exceed \$440,000.00, whereby the County will replace  
15 portions of a failing force main to prevent future health hazards; and

16  
17 WHEREAS, this Council previously adopted Resolution No. 2020-186 authorizing the  
18 Executive to advertise for bids for the Q-615 Pump Station No. 81 Force Main Replacement  
19 Project, located in the City of Tallmadge, in Council District 6, for an estimated total cost not to  
20 exceed \$340,000.00, which was delayed due to Covid-19; and

21  
22 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
23 requires this Council's authorization for the County Executive to advertise for bids for  
24 construction contracts in excess of \$50,000.00; and

25  
26 WHEREAS, a copy of the plans and specifications for the Project are on file with the  
27 Clerk of Council; and

29 WHEREAS, a loan from the Ohio Water Development Authority will be used to fund the  
30 Project, which will be repaid by the County's sanitary sewer enterprise fund; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary, and in the best interest of the County to authorize the County Executive to  
34 advertise for bids for the construction of the aforementioned Project, for an estimated total cost  
35 not to exceed \$440,000.00;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that:

42 The County Executive is hereby authorized to advertise for bids for the Q-615 Pump  
43 Station No. 81 Force Main Replacement Project (the "Project"), located in the City of  
44 Tallmadge, in Council District 6, for an estimated total cost not to exceed \$440,000.00.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take  
13 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall  
14 take effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of the Council concerning and relating  
19 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and of any of its committees that resulted in such formal action,  
21 were in meetings open to the public, in compliance with all legal requirements, including Section  
22 121.22 of the Ohio Revised Code.


