7 **A Resolution confirming the award by the Board of Control of a professional service**  
8 **contract with Telecommunication Technologies Group, LLC, as a Best Practical Source,**  
9 **for cellular support services, including analysis of current cellular services, bill review and**  
10 **contract management and consulting, for a three-year term, for a total amount not to**  
11 **exceed \$97,200.00, for the Office of Information Technology, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2017-273 which authorized  
14 a professional service contract with Telecommunication Technologies Group, LLC (“TTG”), as  
15 a Best Practical Source, to provide project management and support for the County’s Voice Over  
16 Internet Protocol Phone System Upgrade Project; and

17  
18 WHEREAS, TTG is a Best Practical Source due to their extensive knowledge of the  
19 County’s contracts with AT&T, and with our process for cellular deployments and maintenance;  
20 and

22 WHEREAS, the Board of Control, at its meeting held May 26, 2021, awarded a  
23 professional service contract with TTG, as a Best Practical Source, approved by the IT Board on  
24 May 13, 2021, for cellular support services, including analysis of current cellular services, bill  
25 review and contract management and consulting, for a three-year term, for a total amount not to  
26 exceed \$97,200.00, subject to confirmation by Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that the aforementioned purchase contract with TTG, is necessary and in the best interest of the  
30 County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The award by the Board of Control of a professional service contract with  
38 Telecommunication Technologies Group, LLC, as a Best Practical Source, approved by the IT  
39 Board on May 13, 2021, for cellular support services, including analysis of current cellular  
40 services, bill review and contract management and consulting, for a three-year term, for a total  
41 amount not to exceed \$97,200.00, is hereby confirmed and the Executive is hereby authorized to  
42 execute said professional service contract and any other necessary documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and  
47 welfare of the residents of the County of Summit, and for the further reason to immediately  
48 authorize necessary cellular support services for the County.


