7 **A Resolution authorizing the Executive to execute a subgrant agreement with the Ohio**
8 **Department of Job and Family Services, the Ohio Department of Medicaid and the Summit**
9 **County Children Services Board for grants received by Summit County Children Services**
10 **during State Fiscal Years 2022 and 2023, for the period 7/1/21 through 6/30/23, for Summit**
11 **County Children Services, and declaring an emergency.**

13 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
14 that the Ohio Department of Job and Family Services (“ODJFS”) may only make grants to
15 counties through subgrant agreements described in that section; and

16
17 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, ODJFS
18 developed a standard subgrant agreement to be executed by the commissioners, or in the case of
19 a charter county, the executive, of each county prior to receiving ODJFS grant funds; and

20
21 WHEREAS, effective 7/1/17, the State determined it was necessary to add the Ohio
22 Department of Medicaid (“ODM”) to the subgrant agreement due to the County’s receipt of
23 funds from that agency; and

24
25 WHEREAS, Summit County Children Services (“SCCS”) has received from the State the
26 standard subgrant agreement for State Fiscal Years (“SFY”) 2022 and 2023, for the period 7/1/21
27 through 6/30/23, that sets forth the rights and responsibilities of ODJFS, ODM and SCCS in
28 relation to any grant that is awarded for SFY 2022 and 2023; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that is necessary and in the best interest of the County of Summit to authorize the Executive to
32 execute said subgrant agreement with ODJFS, ODM and the SCCS Board for SFY 2022 and
33 2023;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that;

38 SECTION 1

40 The Executive is authorized to execute a subgrant agreement with the Ohio Department
41 of Job and Family Services (“ODJFS”) and Ohio Department of Medicaid (“ODM”) and the
42 Summit County Children Services Board for grants received by Summit County Children
43 Services (“SCCS”) for State Fiscal Years (“SFY”) 2022 and 2023, for the period 7/1/21 through
44 6/30/23. The Executive is hereby authorized to execute said subgrant agreement, a copy of
45 which is attached hereto as Exhibit A and incorporated fully herein, with such modifications and
46 revisions as shall be in furtherance of the provisions of said subgrant agreement and not
47 substantially adverse to the County, all of which shall be conclusively evidenced by the
48 execution thereof by the Executive.

6 This Resolution is declared an emergency in the interest of the health, safety, and welfare
7 of the residents of the County of Summit, and for the further reason that it is necessary to
8 immediately authorize the Executive to execute said subgrant agreement so that SCCS is eligible
9 to be awarded grant funds from ODJFS and ODM for SFY 2022 and 2023 effective 7/1/21.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and any of its committees that resulted in such formal action, were


