7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Oglesby Construction, Inc., for the 2021 Summit County Regional Pavement Marking**
9 **Program, in an amount not to exceed \$229,852.80, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2020-416, which authorized
13 the Executive to advertise as needed for bridge engineering and construction projects, and
14 pavement maintenance projects, for the Engineer's 2021 Capital Improvements Program, for an
15 estimated total cost not to exceed \$9,117,500.00; and

16
17 WHEREAS, said projects were approved as part of the Capital Improvements Program
18 for 2021-2026 by Resolution No. 2021-037; and

19
20 WHEREAS, following the receipt and review of bids, the Executive proposes entering
21 into a construction contract with Oglesby Construction, Inc. for the 2021 Summit County
22 Regional Pavement Marking Program, in an amount not to exceed \$229,852.80; and

24 WHEREAS, the contract total will be broken down by political subdivision as follows
25 with each subdivision responsible for directly paying Oglesby Construction, Inc.:

27 County share: \$175,092.00
28 Copley Twp: \$12,065.20
29 New Franklin: \$19,560.50
30 Sagamore Hills Township: \$4,044.19
31 Twinsburg Township: \$19,090.91; and

33 WHEREAS, the Board of Control, at its meeting held June 23, 2021, awarded a
34 construction contract with Oglesby Construction, Inc., as the lowest responsive and responsible
35 bidder, for the 2021 Summit County Regional Pavement Marking Program, in an amount not to
36 exceed \$229,852.80, subject to confirmation by this Council; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that aforementioned construction contract with Oglesby Construction, Inc. is necessary and in the
40 best interest of the County of Summit.;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that;

47 The award by the Board of Control of a construction contract with Oglesby Construction,
48 Inc., for the 2021 Summit County Regional Pavement Marking Program, in an amount not to
49 exceed \$229,852.80, is hereby confirmed and the Executive is hereby authorized to execute said
50 construction contract and any other necessary related documents.
