7 **A Resolution authorizing the Executive to execute any documents necessary to accept the**
8 **award from the Ohio Department of Public Safety's Office of Criminal Justice Services, of**
9 **a Drug Law Enforcement Fund grant, in the amount of \$118,421.82, with a 25% local cash**
10 **match requirement of \$39,473.95, for a total amount of \$157,895.77, for the period 7/1/21**
11 **through 6/30/22, for the Sheriff, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services,
14 ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Law Enforcement Fund ("DLEF")
15 grant in the amount of \$118,421.82, with a 25% local cash match requirement of \$39,473.95, for
16 a total amount of \$157,895.77, for the period 7/1/21 through 6/30/22; and

18 WHEREAS, the local cash match will be paid from the Summit County Drug Unit
19 checking account; and

21 WHEREAS, the DLEF grant will fund a countywide drug unit task force which will
22 specifically target the manufacture, distribution and acquisition of illegal drugs in Summit
23 County; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned DLEF grant from
28 the ODPS-OCJS;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The Executive is hereby authorized to execute any documents necessary to accept the
36 award by the Ohio Department of Public Safety's Office of Criminal Justice Services ("ODPS-
37 OCJS") of a Drug Law Enforcement Fund ("DLEF") grant in the amount of \$118,421.82, with a
38 25% local cash match requirement of \$39,473.95, for a total amount of \$157,895.77, for the
39 period 7/1/21 through 6/30/22.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit and for the further reason to immediately allow
45 the DLEF grant funds from ODFS-OCTS to be used by the countywide drug unit task force to
46 address the problem of illegal drugs in Summit County.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take


