A Resolution approving a collective bargaining agreement between the Summit County Court of Common Pleas, General Division, Adult Probation Department and Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO (Common Pleas, Adult Probation Department Unit), for the period 10/1/2021 through 9/30/2024, for the Court of Common Pleas, General Division, and declaring an emergency.

WHEREAS, the Summit County Court of Common Pleas opted to voluntarily recognize a collective bargaining unit consisting of its Probation Officers and certain Probation Department support workers and organized by Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO; and

WHEREAS, a collective bargaining agreement has been negotiated and agreed to in principle between the Summit County Court of Common Pleas, General Division, Adult Probation Department and Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO, for the period 10/1/2021 through 9/30/2024; and

WHEREAS, although the Summit County Court of Common Pleas' collective bargaining agreement (as a non-Charter state entity) is outside the scope of the County Executive's authority to negotiate collective bargaining agreements conferred by the Summit County Charter, Section 4117.10 of the Ohio Revised Code vests with this Council, as the legislative authority that appropriates funds for the Court of Common Pleas' operations, the express authority to approve or reject the aforementioned agreement; and

WHEREAS, the authority conferred under Section 4117.10 to approve or reject the aforementioned agreement is the authority to approve or reject the agreement as a whole, and the legislative authority does not have authority to reject certain provisions of the agreement while approving others; and

WHEREAS, this Council has determined that approving the agreement as a whole is in the best interest of the County.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
