7 **A Resolution confirming the award of the Board of Control of a purchase contract with**  
8 **Powerschool Group, LLC, dba PeopleAdmin, Inc., as a Best Practical Source, subject to the**  
9 **approval of the IT Board, for the implementation and maintenance of a human resource**  
10 **management system, for a one-year term, from 3/18/22 to 3/17/23, in a total amount not to**  
11 **exceed \$74,272.06, for the Executive's Department of Human Resources, and declaring an**  
12 **emergency.**

14 WHEREAS, the County has used PeopleAdmin software since 2014, which at the time of  
15 its purchase was the only human resource management system that integrated with the County's  
16 financial accounting system which along with PeopleAdmin being proprietary and requiring  
17 software licensing, updates and software support makes it a Best Practical Source; and

18  
19 WHEREAS, the Board of Control, at its meeting held September 22, 2021, awarded a  
20 purchase contract with Powerschool Group, LLC, dba PeopleAdmin, Inc. ("Powerschool Group,  
21 LLC"), as a Best Practical Source, subject to the approval of the IT Board, for the implementation  
22 and maintenance of a human resource management system, for a one-year term, from 3/18/22 to  
23 3/17/23, in a total amount not to exceed \$74,272.06; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that the aforementioned purchase contract with Powerschool Group LLC, subject to the approval  
27 of the IT Board, is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

34 The award by the Board of Control of a purchase contract with Powerschool Group, LLC,  
35 dba PeopleAdmin, Inc. ("Powerschool Group, LLC"), as a Best Practical Source, subject to the  
36 approval of the IT Board, for the implementation and maintenance of a human resource  
37 management system, for a one-year term, from 3/18/22 to 3/17/23, in a total amount not to exceed  
38 \$74,272.06, is hereby confirmed and the Executive is hereby authorized to execute said purchase  
39 contract and any related necessary documents.

41 SECTION 2

43 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
44 and welfare of the residents of the County of Summit, and for the further reason to continue to  
45 provide for necessary human resource management system services for the County.

47 SECTION 3

49 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
50 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
51 be in force at the earliest time provided by law.


