7 **A Resolution authorizing the Executive to advertise for bids for a Laundry Service**
8 **Management agreement for laundry services at the Jail, located in the City of Akron, in**
9 **Council District 5, for a one-year term, for an estimated total cost not to exceed**
10 **\$240,000.00, for the Sheriff, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council’s authorization for the Executive to advertise for bids; and

15 WHEREAS, the Executive wishes to advertise for bids for a Laundry Service
16 Management agreement for laundry services at the Jail, located in the City of Akron, in Council
17 District 5, for a one-year term, for an estimated total cost not to exceed \$240,000.00; and

19 WHEREAS, currently, laundry services are completed by inmate Trustees; and

20

21 WHEREAS, the Sheriff wishes to outsource laundry services at the jail due to operational
22 need; and

24 WHEREAS, a copy of the bid specifications is on file with the Clerk of Council; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
28 for bids for a Laundry Service Management agreement for laundry services at the Jail;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The Executive is hereby authorized to advertise for bids for a Laundry Service
36 Management agreement for laundry services at the Jail, located in the City of Akron, in Council
37 District 5, for a one-year term, for an estimated total cost not to exceed \$240,000.00.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare
42 of the residents of the County of Summit, and for the further reason that it authorizes the
43 Executive to immediately advertise for bids for the aforementioned Laundry Service
44 Management agreement.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.


