7 **A Resolution confirming the award by the Board of Control of a renewal (first of four) for a**  
8 **professional service contract with Oriana House, Inc. for community corrections services for**  
9 **a one-year term, from 1/1/24 through 12/31/24, in an amount not to exceed \$9,250,340.35, for**  
10 **the Executive’s Department of Public Safety, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2023-021, which confirmed  
13 the award by the Board of Control of professional service contract with Oriana House, Inc., for  
14 day reporting, driver intervention, home incarceration, multiple offender, and residential  
15 community correction programming, for a one year term, from 1/1/24 through 12/31/24, with four  
16 options to renew for an additional one-year term, in an amount not to exceed \$8,980,912.97, for  
17 the Executive’s Department of Public Safety

19 WHEREAS, the Board of Control, at its meeting held January 3, 2024, awarded a renewal  
20 (first of four) of a professional service contract with Oriana House, Inc. for community corrections  
21 services for a one-year term, from 1/1/24 through 12/31/24, in an amount not to exceed  
22 \$9,250,340.35, subject to confirmation by this Council; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that the  
25 aforementioned renewal with Oriana House, Inc. is necessary and in the best interest of the County  
26 of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

33 The award by the Board of Control of a renewal (first of four) of a professional service  
34 contract with Oriana House, Inc. for community corrections services for a one-year term, from  
35 1/1/24 through 12/31/24, in an amount not to exceed \$9,250,340.35, is hereby confirmed and the  
36 Executive is hereby authorized to execute said professional service contract and any necessary  
37 related documents.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the residents of the County of Summit, and for the further purpose of immediately  
43 providing community corrections services effective 1/1/24.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
48 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
49 be in force at the earliest time provided by law.
