7 **A Resolution confirming the award by the Board of Control of a renewal (first of two) of a**
8 **professional service contract with AdvizeX Technologies LLC, for PureStorage Solution**
9 **for SAN, for a one-year term, from 5/1/2024 through 4/30/2025, in an amount not to exceed**
10 **\$104,580.00, for the Office of Information Technology, and declaring an emergency.**

12 WHEREAS, AdvizeX was selected to replace the previous Information Technology
13 storage system that went out of support in October of 2023 and to provide additional storage
14 functionality and flexibility to increase storage with only additional subscription costs and no
15 additional hardware; and

16

17 WHEREAS, this Council previously adopted Resolution 2023-242, which confirmed the
18 award by the Board of Control of a professional services contract with AdvizeX; and

19

20 WHEREAS, the Office of Information Technology recommends renewing the contract
21 with AdvizeX for continued service; and

23 WHEREAS, the Board of Control, at its meeting held on March 13, 2024, awarded a
24 renewal (first of two) of a professional service contract with AdvizeX Technologies LLC, for
25 PureStorage Solution for SAN, for a one-year term, in an amount not to exceed \$104,580.00,
26 subject to confirmation by this Council; and

28 WHEREAS, the Information Technology Board, at its meeting held on March 7, 2024,
29 approved the aforementioned contract; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that the aforementioned renewal of a professional service contract with AdvizeX Technologies
33 LLC is necessary and in the best interest of the County of Summit;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 The award by the Board of Control of a renewal (first of two) of a professional service
41 contract with AdvizeX Technologies LLC, approved by the Information Technology Board, for
42 PureStorage Solution for SAN, for a one-year term, from 5/1/2024 through 4/30/2025, in an
43 amount not to exceed \$104,580.00, is hereby confirmed and the Executive is hereby authorized
44 to execute said professional service contract and any other necessary related documents.
