7 **A Resolution authorizing the Executive to enter into an intergovernmental agreement with**
8 **the City of Twinsburg and the City of Reminderville concerning the resurfacing of Liberty**
9 **Road, located in the City of Twinsburg, the City of Reminderville, and Twinsburg**
10 **Township, in Council District 1, for the Executive and Engineer, and declaring an**
11 **emergency.**

13 WHEREAS, the Engineer has determined Liberty Road from 100 feet south of Post Road
14 to the Cuyahoga County line, located in the City of Twinsburg, the City of Reminderville, and
15 Twinsburg Township, is in need of resurfacing (the “Project”); and

16
17 WHEREAS, the City of Reminderville has secured federal Surface Transportation Block
18 Grant funds in the amount of \$684,00.00 for the construction of the Project; and

19
20 WHEREAS, approximately 27.77% of the paved surface is located in the City of
21 Reminderville, 61.03% is located in the city of Twinsburg, and 11.21% is in Twinsburg
22 Township; and

24 WHEREAS, the City of Reminderville has agreed to take the lead on the Project; and

26 WHEREAS, it is necessary for the parties to execute an intergovernmental agreement to
27 set forth the rights and duties of the parties concerning the design and construction of the Project,
28 as detailed in Exhibit A, a copy of which is attached to the Resolution and incorporated herein as
29 if fully restated; and

31 WHEREAS, this Council has determined by reviewing all pertinent information that it is
32 necessary and in the best interest of the County of Summit to authorize the Executive to enter
33 into an intergovernmental agreement with the City of Twinsburg and the City of Reminderville
34 for the aforementioned Project;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that;

39 SECTION 1

41 The Executive is hereby authorized to execute an intergovernmental agreement with the
42 City of Twinsburg and the City of Reminderville to outline responsibilities and financial
43 contributions for the Liberty Road Resurfacing Project. The final agreement will be substantially
44 in the same form as the agreement attached hereto as Exhibit A, and incorporated herein as if
45 fully restated, with such modifications and revisions as shall be in furtherance of the provisions
46 of said intergovernmental agreement and not substantially adverse to the County, all of which
47 shall be conclusively evidenced by the execution thereof by the Executive.

SECTION 2
