11 WHEREAS, the County of Summit's Computerization Fund is established by Section
12 2303.201(A)(1) of the Ohio Revised Code, which also permits the funding of it though the
13 collection of court fees; and

15 WHEREAS, it is necessary to appropriate funds in the amount of \$3,000.00 for the
16 purchase of computer supplies within Juvenile Court's Computerization Fund through 12/31/09;

19 WHEREAS, a court's Special Projects Fund is established by Section 2303.201(E)(1) of
20 the Ohio Revised Code, which also permits the funding of it though the collection of court fees;

23 WHEREAS, it is necessary to appropriate funds in the amount of \$10,000.00 for
24 mediation services in dependency/neglect cases through Juvenile Court's Special Projects Fund
25 through 12/31/09; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that the
28 appropriation of the aforementioned funds is necessary and in the best interest of the County of
29 Summit;
