An Ordinance enacting Section 113.13 of the Codified Ordinances of the County of Summit, entitled "Lead Testing Fee," to establish a fee to be charged by the County when performing lead tests on rehabilitated structures, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the Executive's Department of Community and Economic Development is the owner of certain lead testing equipment, and desires to contract with persons or entities who are rehabilitating homes within Summit County to test for the presence of lead in those homes; and

WHEREAS, the County incurs certain costs in the performance of said lead tests and the maintenance of the equipment necessary to perform said tests; and

WHEREAS, it is necessary to adopt a new Section of the Codified Ordinances of the County of Summit to establish a fee that the Department of Community and Economic Development may charge a person or entity for which it performs a lead test; and

WHEREAS, this Council finds and determines that it is necessary and in the best interest of the County of Summit to enact Section 113.13 of the Codified Ordinances of the County of Summit, entitled "Lead Testing Fee" to establish a fee for lead testing performed by the Department of Community and Economic Development.

NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State of Ohio, that:

Section 113.13 of the Codified Ordinances of the County of Summit, entitled "Lead Testing Fee," is hereby enacted as follows:

### 113.13 Section 133.13 Lead Testing Fee

Any person or entity contracting with the County for the Department of Community and Economic Development to perform testing for the existence of lead levels within a structure shall pay the following fees to the County:

Initial Lead Test	\$350.00
Lead Clearance Test	\$150.00

The proceeds from the payment of said fees shall be used by the Department of Community and Economic Development for costs associated with the testing, including, but not limited to, labor, material, equipment, supplies, maintenance and any other associated costs.

## **SECTION 2**

This Ordinance is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further purpose of immediately establishing said fee so that the County may begin performing the aforementioned lead tests.

# **SECTION 3**

Provided this Ordinance receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

#### **SECTION 4**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
