7 **A Resolution authorizing the County Executive to execute any documents necessary to**
 8 **accept Workforce Investment Act ("WIA") funds from the Ohio Department of Job and**
 9 **Family Services ("ODJFS") for the One-Stop Resource Sharing Partner Agreement, for**
 10 **the period 7/1/09 through 6/30/10, in the amount of \$42,882.00, and appropriating these**
 11 **funds for expenditures through 2009, for the Executive's Department of Job and Family**
 12 **Services, and declaring an emergency.**
 13

14 WHEREAS, ODJFS provides WIA funds for "rent" for mandatory ODJFS staffing at the
 15 Summit County Job Center, through the One-Stop Resource Sharing Partner Agreement, for a
 16 program formerly known as the Ohio Bureau of Employment Services ("OBES"), for the period
 17 7/1/09 through 6/30/10, in the amount of \$42,882.00; and
 18

19 WHEREAS, this Council has determined by reviewing all pertinent information that it is
 20 necessary and in the best interest of the County of Summit to authorize the Executive to execute
 21 any documents necessary to accept the aforementioned WIA funds from ODJFS and to
 22 appropriate these funds;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,
 25 State of Ohio, that:

29 The County Executive is hereby authorized to execute any documents necessary to accept
 30 the WIA funds from ODJFS for the period 7/1/09 through 6/30/10, in the amount of \$42,882.00,
