7 **An amended Resolution authorizing the County Executive to execute a contract renewal**
8 **(second of two), subject to approval of the Board of Control, with Medical Mutual of Ohio**
9 **to provide medical insurance coverage, administrative services and reinsurance for County**
10 **employees, for the period 1/1/10 through 12/31/10, at the rates set forth on amended**
11 **Exhibit A, for the Executive's Department of Insurance and Risk Management, and**
12 **declaring an emergency.**

14 WHEREAS, Resolution No. 2007-486 authorized entering into a contract with Medical
15 Mutual of Ohio to provide medical insurance coverage, administrative services and reinsurance
16 for County employees for the period of one year with two options to renew for an additional one
17 year period; and

19 WHEREAS, Resolution No. 2008-494 exercised the option and authorized the renewal
20 of said contract with Medical Mutual of Ohio for a one year period from 1/1/09 through
21 12/31/09; and

23 WHEREAS, County Council has determined by reviewing all pertinent information that
24 the aforementioned contract is necessary and in the best interest of the County of Summit;

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,

31 The County Executive is hereby authorized to execute a contract renewal (second of
32 two), subject to approval of the Board of Control, with Medical Mutual of Ohio to provide
33 medical insurance coverage, administrative services and reinsurance for County employees, for
34 the period 1/1/10 through 12/31/10, at the rates set forth on amended Exhibit A.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason to immediately
40 provide continued medical insurance coverage for employees.

45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take




