7 **A Resolution of support for an Economic Adjustment Assistance grant application to the**
8 **Economic Development Administration, with the City of Twinsburg as the lead applicant**
9 **and the County of Summit as a co-applicant, for the Executive's Department of**
10 **Community and Economic Development, and declaring an emergency.**

11
12 WHEREAS, the Public Works and Economic Development Act of 1965, 42 U.S.C.
13 Sections 3132-3233, as amended, delegates to the Economic Development Administration
14 ("EDA") responsibility of assisting in the development of multi-county planning districts
15 through project grants which assure effective utilization of local resources in creating full-time
16 permanent jobs for the unemployed and the underemployed; and

18 WHEREAS, the purpose of the 1998 amendment to the Act was to further authorize
19 economic assistance in the form of planning, and implementation grants under Title I and II to
20 areas experiencing unemployment caused by structural changes in the area's economy; and

22 WHEREAS, the EDA is authorized through planning and implementation grants to assist
23 area planning efforts to solve problems of economic growth, unemployment and
24 underemployment; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit that the County affirms its support for
28 the Economic Adjustment Assistance application to the Economic Development Administration;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

33 SECTION 1

35 The County of Summit hereby states its support for the City of Twinsburg and County of
36 Summit Economic Adjustment Assistance grant application to the Economic Development
37 Administration to use as funding in developing a strategic response to the imminent closure of
38 the Chrysler Twinsburg Stamping plant and subsequent economic dislocations.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the citizens of the County of Summit and for the further purpose of immediately
44 declaring the County's support for an Economic Adjustrnt Assistant grant application to the
45 EDA by the City of Twinsburg and the County.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
