7 **A Resolution appropriating funds for the Domestic Violence Trust Fund as required by**
8 **Section 3113.35 of the Ohio Revised Code, in the amount of \$120,000.00, the projected**
9 **receipts by the Fund for the period 1/1/10 through 12/31/10, to be paid to the Battered**
10 **Women's Shelter, for the Executive, and declaring an emergency.**

12 WHEREAS, Section 3113.35 of the Ohio Revised Code ("ORC") requires that funds
13 must be collected from Probate Court's marriage fees and the Clerk of Courts' Divorce-
14 Annulment-Dissolution fees in 2010 be deposited into the Domestic Violence Fund; and

15
16 WHEREAS, the Battered Women's Shelter has submitted an application pursuant to
17 ORC § 3113.35 for the aforementioned funds to be collected in 2010 and is eligible for payment
18 of said funds; and

20 WHEREAS, funds deposited for the Domestic Violence Fund under ORC 3113.35 in the
21 period 1/1/10 through 6/30/10 are to be paid out by 7/15/10; and

23 WHEREAS, funds deposited for the Domestic Violence Fund under ORC 3113.35 in the
24 period 7/1/10 through 12/31/10 are to be paid out by 1/15/11; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that the
27 appropriations of the aforementioned funds is necessary and in the best interest of the County of
28 Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

14 effect and be in force at the earliest time provided by law.


