12 award of \$749,949.00 from the United States Department of Justice ("DOJ") to fund a Domestic
13 Violence Unit for the period 9/1/07 through 8/31/09, and extended by the DOJ in 2009 to
14 12/31/09; and,

16 WHEREAS, \$11,400.00 in original appropriations require an adjustment in order to
17 provide services and fund payroll expenditures; and

19 WHEREAS, this Council has determined by reviewing all pertinent information that the
20 adjustment of the appropriation of the aforementioned grant fund is necessary and in the best
21 interest of the County of Summit;


