9 **A Resolution appropriating a total of \$500,000.00 for a State Fiscal Year 2009 Workforce**
10 **Investment Act (“WIA”) grant received as a result of the American Recovery and**
11 **Reinvestment Act (“ARRA”) of 2009 for a Rapid Response initiative, with a partial**
12 **appropriation for the period 7/1/09 through 12/31/09 in the amount of \$50,000.00 and the**
13 **balance of \$450,000.00 for the period 1/1/10 through 6/30/10, for the Executive’s**
14 **Department of Job and Family Services, and declaring an emergency.**

15
16 WHEREAS, pursuant to Resolution No. 2009-088, the County Executive is authorized
17 to execute any documents necessary to accept the ARRA additional funds, including executing
18 and submitting a substantial amendment to the Annual Action Plan, but said funds must be
19 appropriated prior to being spent; and

21 WHEREAS, the Department of Job and Family Services has received an allocation of
22 WIA funds under ARRA in the amount of \$500,000.00 for a Rapid Response initiative to
23 establish and support an Employment Transition Center targeting workers affected by the auto
24 industry related dislocation events; and

25
26 WHEREAS, this award is on State Fiscal Year 2009 (7/1/09 through 6/30/10) and the
27 Department of Job and Family Services require funds immediately in each of the calendar years
28 in order to assist adult dislocated workers who have lost their jobs as a result of the Chrysler
29 Stamping Plant closing in Twinsburg to obtain employment and/or training; and

31 WHEREAS, this Council has determined by reviewing all pertinent information that it is
32 necessary and in the best interest of the County of Summit to appropriate the aforementioned
33 funds in the amount of \$50,000.00 for the period 7/1/09 through 12/31/09 and \$450,000.00 for
34 the period 1/1/10 through 6/30/10, received from the ARRA grant;
