7 **A Resolution authorizing the County Executive to advertise for bids to provide food service**
8 **to Detention Center youth, for a one-year term from 7/1/10 through 6/30/11, with four**
9 **options to renew for an additional one-year term, for an estimated cost not to exceed**
10 **\$300,000.00 for the first year, for the Juvenile Court, and declaring an emergency.**

12 WHEREAS, the current food service contract for Detention Center youth will expire
13 12/18/09, and the Ohio Department of Education, Office for Safety, Health and Nutrition
14 requires all entities receiving school lunch reimbursements that a procurement bidding process is
15 required; and

17 WHEREAS, a request is currently before the Board of Control to renew the current
18 contract through 6/30/10; and

20 WHEREAS, it is required that the new contract be in place by 7/1/10; and

22 WHEREAS, the Juvenile Court wishes that the County Executive be authorized to
23 advertise for bids for a new food service contract, for a one-year term from 7/1/10 through
24 6/30/11, with four options to renew for an additional one-year term, for an estimated cost not to
25 exceed \$300,000.00 for the first year; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the County Executive to
29 advertise for bids;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
32 State of Ohio, that:

36 The County Executive is hereby authorized to advertise for bids for to provide food
37 service to Detention Center youth, for a one-year term from 7/1/10 through 6/30/11, with four
38 options to renew for an additional one-year term, for an estimated cost not to exceed \$300,000.00

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the citizens of the County of Summit and for the further purpose of immediately
45 authorizing the County Executive to advertise for bids for the aforementioned food service
46 contract.

50 Provided this Resolution receives the affirmative vote of eight members of this Council,
51 it shall take effect immediately upon its adoption and approval by the County Executive;
52 otherwise, it shall take effect and be in force at the earliest time provided by law.
