7 **A Resolution, pending Board of Control approval, authorizing the Executive to execute**  
8 **Temporary Assistance to Needy Families (TANF) Agreements with two Providers, attached**  
9 **hereto as Exhibit A and incorporated herein as if fully restated, utilizing funds from the**  
10 **American Recovery and Reinvestment Act (ARRA) TANF Emergency Contingency Fund**  
11 **as allocated by the Ohio Department of Job and Family Services for a TANF Subsidized**  
12 **Summer Employment Program for Youth Allocation as well as funds from the Executive's**  
13 **Department of Job and Family Services' formulary TANF Allocation in an amount not to**  
14 **exceed \$560,540.64 for the Executive's Department of Job and Family Services and**  
15 **declaring an emergency.**

16  
17 WHEREAS, the American Recovery and Reinvestment Act of 2009 ("ARRA") provided  
18 Summit County with TANF Emergency Contingency federal stimulus allocations for allowable  
19 expenditures made between 6/1/10 and 8/31/10 with a liquidation period by 9/30/10; and

21 WHEREAS, this Council is currently considering a Resolution which will authorize the  
22 County Executive to accept the award by the Ohio Department of Job and Family Services  
23 (ODJFS) of \$2,266,474.00 in TANF Emergency Contingency allocation and appropriating said  
24 allocations; and

26 WHEREAS, the County of Summit wishes to enact Agreements with the providers listed  
27 in Exhibit A, attached hereto and incorporated herein as if fully restated, and to authorize the  
28 County Executive to execute said Agreements, subject to the approval of the Board of Control,  
29 with said providers, for youth summer employment programs, for the period 6/1/10 through  
30 9/30/10, in a total amount not to exceed \$560,540.64; and

32 WHEREAS, subject to Board of Control approval, this Council has determined by  
33 reviewing all pertinent information that these Agreements are necessary and in the best interest  
34 of the County of Summit.

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The award, pending Board of Control approval, of TANF Agreements for the period June  
42 1, 2010, through September 30, 2010, with the Providers listed on Attachment "A" in an amount  
43 not to exceed \$560,540.64, is hereby confirmed, and the County Executive is authorized to  
44 execute all related documents.

48 The Resolution is hereby declared an emergency in the interest of the health, safety, and  
49 welfare of the citizens of the County of Summit and for the further reason that the Agreements  
50 are needed in order to enact a Summer Youth Employment Program in Summit County.
