7 **A Resolution appropriating federal TANF (Temporary Assistance to Needy Families)**
8 **funds from the Summit County Department of Job and Family Services (“DJFS”) in a total**
9 **amount of \$924,222.00 for the Youth Employment for Success (“YES”) Summer 2010**
10 **Program, which includes TANF ARRA (American Recovery and Reinvestment Act) funds**
11 **in the amount of \$677,422.00 for the summer employment of youth, and regular TANF**
12 **funds as matching funds in the amount of \$246,800.00 for supervision and administrative**
13 **expenses, for the period 6/1/10 through 9/30/10, for the Executive’s Department of**
14 **Communications’ Youth Employment for Success (“YES”) program, and declaring an**
15 **emergency.**

17 WHEREAS, the American Recovery and Reinvestment Act of 2009 (“ARRA”) was
18 signed into Law by President Obama on 2/27/2009; and,

19
20 WHEREAS, ARRA TANF funds were made available to the Executive’s Department of
21 Job and Family Services for a Summer Youth Employment Program and are being appropriated
22 in Resolution No. 2010-245 for programs to be in operation in June, July, and August of 2010;
23 and

25 WHEREAS, the TANF ARRA funds are restricted by the State of Ohio DJFS for youth
26 wages and any required related benefits costs for an employment period beginning 6/1/10 and
27 ending no later than 8/31/10; and

29 WHEREAS, matching funds from regular TANF funding are require to support the
30 Summer Program’s administrative costs including supervision and administrative expenses; and

32 WHEREAS, Summit County has provided employment opportunities to at-risk youth for
33 nearly 30 years and are currently administered by the County of Summit’s YES programs that
34 now include job readiness training, paid work experience, mentoring and guidance services to
35 the youths of Summit County to help them meet their academic and career goals; and

37 WHEREAS, the Summit County Department of Job and Family Services will provide
38 YES with TANF ARRA grant awards to exclusively fund the wages and required benefits for up
39 to 400 summer youth employees in the program starting June 1, 2010 and ending August 31,
40 2010, and

42 WHEREAS, the Summit County Department of Job and Family Services will provide
43 YES with regular TANF grant awards to fund the wages for supervisors of youth and
44 administration costs for the YES TANF Summer Youth Employment Program; and

46 WHEREAS, this Council has determined by reviewing all pertinent information that it is
47 necessary and in the best interest of the County of Summit to appropriate the aforementioned
48 funds in the amount of \$677,422.00 from the ARRA TANF fund and \$246,800.00 from the
49 regular TANF funding; and
