14 contracts to provide the aforementioned services, subject to confirmation by County Council;

18 the contracts are necessary and in the best interest of the County of Summit;

25 The award by the Board of Control of various professional service contracts per attached
26 Exhibit A for employment services to adults with a non-violent felony criminal record, for the
27 period 7/1/10 to 6/30/11, with two options to renew for a one-year period, in a total amount not
28 to exceed \$320,000.00, is hereby confirmed and the County Executive is hereby authorized to
29 execute such contracts.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned services.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
