19 that the classification, classification specification and salary schedule for the non-bargaining
20 classified position of HRC Administrator #90211 be approved; and

23 the classification, classification specification and salary schedule for the aforementioned
24 position, as stated in Order 10-02, attached hereto as Exhibit A and incorporated herein as if fully
