7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **Pavement Technology, Inc., for the 2010 Asphalt Rejuvenating Program, in an amount not**  
9 **to exceed \$86,062.00, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held June 23, 2010, awarded a contract  
12 to provide the aforementioned program, subject to confirmation by County Council; and,

14 WHEREAS, County Council has determined by reviewing all pertinent information that  
15 the contract is necessary and in the best interest of the County of Summit;

17 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

22 The award by the Board of Control of a construction contract with Pavement Technology,  
23 Inc., for the 2010 Asphalt Rejuvenating Program, in an amount not to exceed \$86,062.00, is  
24 hereby confirmed and the County Executive is hereby authorized to execute such contract.

28 This Resolution is hereby declared an emergency in the interest of the health, safety and  
29 welfare of the citizens of the County of Summit, and for the further reason to immediately  
30 provide the aforementioned program.

34 Provided this Resolution receives the affirmative vote of eight members, it shall take  
35 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
36 effect and be in force at the earliest time provided by law.

40 It is found and determined that all formal actions of this Council concerning and relating  
41 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
42 deliberations of this Council and of any of its committees that resulted in such formal action,

44 121.22 of the Ohio Revised Code.
