7 **A Resolution authorizing the County Executive to advertise for bids for the Jail Renovation**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

14 WHEREAS, the County Executive wishes to advertise for bids for the Jail Renovation
15 Project, for an estimated total cost not to exceed \$1,578,000.00; and

17 WHEREAS, a copy of the bid specifications are on file in the office of the Clerk of
18 Council; and

20 WHEREAS, this Council has determined by reviewing all pertinent information that is
21 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
22 for bids for the aforementioned project;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

29 The County Executive is authorized to advertise for bids for the Jail Renovation Project
30 for an estimated total cost not to exceed \$1,578,000.00.

34 This Resolution is declared an emergency in the interest of the health, safety, and welfare
35 of the citizens of the County of Summit, and for the further reason that it immediately authorizes
36 the Executive to advertise for bids for the Jail Renovation Project.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and any of its committees that resulted in such formal action, were
